The Christmas Box International partners with local, national and international communities and groups to prevent child abuse and to improve the quality of life for children, teens and young adults who have been abused, neglected or are facing homelessness. Our motto is simple: every child deserves a childhood.

Provided resources to 9,155 children, youth and young adults who have been abused, neglected or faced homelessness in Utah and in 4 countries in collaboration with partnering child welfare agencies and charities serving children, teens, and young adults.

The Christmas Box Houses Support Services:

The Christmas Box Houses (CBH) in Salt Lake City, Ogden, and Moab were created and built by The Christmas Box International to ensure that no child enters state custody alone, unseen, or afraid. Working hand-in-hand with Utah's state and county child-welfare agencies, the Houses provide immediate emergency shelter for children who have been removed from their homes because of abuse, neglect, trafficking, or homelessness.

But they offer far more than a bed and a roof. Each child receives compassionate care, health and therapeutic support, assessments, educational stability, and opportunities simply to be a child again through play and recreation. Thoughtful touches - like book nooks filled with new stories and blanket rooms stocked with soft, cozy blankets - help restore a sense of safety and dignity during a frightening time.

This past year, 810 children were sheltered, supported, and cared for at the three Christmas Box Houses. Across all locations, an average of 39 sibling groups are served each month - meaning nearly 1,000 brothers and sisters are able to stay together each year rather than being separated during crisis. For many, that connection becomes the lifeline that carries them through uncertainty and trauma.

The Christmas Box Houses also provide specialized support for children with significant medical, emotional, or behavioral needs until a safe, longer-term placement can be secured with kinship families or foster care. Every child who walks through these doors is reminded: you matter, you are seen, and you are worth protecting.

Across 22 Utah counties, our twenty-three Christmas Box Resource Rooms ensure that children and teens in crisis never go without the essentials - or the dignity - they deserve. Each Resource Room is lovingly stocked with new, donated items including clothing, shoes, bedding, baby supplies, school and hygiene kits, books, household goods, and toys. These aren't leftovers - they are gifts of hope, carefully prepared so every child knows they matter.

These resources support children and youth who are:

- staying at The Christmas Box Emergency Shelters
- living in Transition to Adult Living Homes
- currently in Foster Care or preparing to age out
- receiving Human Services In-home Services
- being Raised by grandparents or relatives
- served internationally through trusted nonprofit partners serving 7 countries

In the past year, our Utah Resource Rooms provided essential support to 2,214 children and young adults - easing the financial burden on foster parents, kinship families, and at-risk youth taking their first brave steps into adulthood.
